2017-2018 Selective Service Registration

The Department of Education has not confirmed that you are registered for Selective Service, an eligibility requirement for Federal Student Aid. Most male students must register with Selective Service to receive federal aid. Please indicate in PART 1 the method you will use to register or use PART 2 to explain and present proof of reason for non-registration.

PART 1. To Register for Selective Service

Please check the appropriate statement:

- I would like the Financial Aid Office to update my FAFSA by selecting "Register Me" on the FAFSA.
- I will select "Register Me" at the Selective Service registration question on the Free Application for Federal Student Aid (FAFSA). (Aid will not be awarded until the Financial Aid Office receives the updated FAFSA).
- I will register online at www.sss.gov and submit proof of registration to the Financial Aid Office.

PART 2. To Explain and Present Proof of Reason for Non Registration

In order to receive financial aid, you must prove one of the following situations applies. Please check the appropriate statement:

- I did not register for Selective Service because I was not within 30 days of turning 18 years of age when I completed my FAFSA.
- I am not required to register because I am female.
- I am not required to register for Selective Service because I was born before 1960.
- I am currently serving on active duty in the U.S. Armed Forces. *Please submit proof of service.* (A student who is in the National Guard or Selected Reserves and not on active duty does not meet this exemption.)
- I served on active duty in the U.S. Armed Forces until after I turned 26. *Please submit a copy of your DD-214 form.* (A student who was in the National Guard or Selected Reserves and not on active duty does not meet this exemption.)
- I am/was a non-citizen who entered this country after the age of 26. *Please provide a valid document such as the Passport with date stamp used to enter the United States.*
- I am/was a noncitizen who entered the U.S. as lawful nonimmigrant on a valid visa and remained in the U.S. on the terms of that visa until after I turned 26. *Please provide a valid document as proof of this statement.*
- None of the above statements apply to me. Students who are not clearly exempt from the registration requirement must submit a *Status Information Letter* from Selective Service (www.sss.gov) and provide a statement of explanation of non-registration. NCC Financial Aid may require more information from you and will make a determination on your eligibility after a review of all the information.

By signing I/we certify that all of the information I/we provided is true and complete to the best of my/our knowledge and I/we agree, if asked, to provide information that will verify the accuracy of this completed form.
