



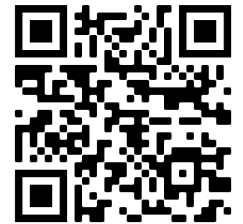

The faculty and staff of Nashua Community College and its Nursing Program are facilitating the education of the next generation of nurses. Our career-experienced faculty support the student's development through comprehensive classroom instruction, in-depth scenarios in a state-of-the-art simulation lab and purposeful clinical placements that allow for theory and practice to be integrated for optimal learning.

In addition to reinforcing ethical, professional, caring and compassionate behavior, the faculty are promoting critical thinking in all our graduates so they are proactive rather than reactive nurses.

All this is done in a small class size of 32 students, which allows for personalized attention that larger programs cannot provide. Students who complete the nursing program are prepared to take the National Council of State Boards of Nursing Licensing Exam (NCLEX) to practice as an entry-level registered nurse.
